NEW REALITIES NEW OPPORTUNITIES

HANS SKOV CHRISTENSEN

The economic and financial crisis has made for a turbulent last few years but courageous structural reforms across Baltic countries have cemented the Baltic Sea Region as not only a role model but as a well performing area in Europe. For this reason alone, optimism about the future is on the increase.

Latvia has proven to be the epitome of our title at this year's Summit and this is established furthermore in a marvelous book I received personally from Prime Minister Valdis Dombrovskis, entitled 'How Latvia Came through the Financial Crisis', when he opened BDF's new office premises in Copenhagen last year.

Along with Prof. Anders Åslund, Valdis Dombrovskis shares in his book, insights into just how Latvia has returned to economical growth after a relatively short period of time. Respect is due to PM Dombrovskis for the stabilisation we now see in Latvia. The economical and political lessons learned are there for all to see.

It was also an important signal PM Dombrovskis, the Minister of Finance, Andris Vilks, and the President of the Bank of Latvia, Ilmārs Rimšēvics, sent 4 March when they signed a joint letter asking the European Commission and the European Central Bank for a convergence report that is related to the formal accession to the Eurozone. Presently, Latvia fulfills all the Maastricht criteria so the target date 1 January 2014 is within reach. In the wake of the economic crisis and wide spread EU scepticism, Europe needs countries that demonstrate their will to take new steps for further European integration. We need positive European integration winds from Latvia and the Baltic States.



Although there is reason for optimism, sustainable growth is yet to be achieved throughout the Baltic Sea region and key words throughout the BDF Summit are competitiveness, business development, manufacturing and investment. Now is the time to push the new realities we have witnessed from globalisation and Europe's own economic troubles into real opportunities. This will be vital in financing the Baltic Sea Regions future.

I am sure that the Baltic Sea Region has entered the second positive economic phase similar to the one we saw 20 years ago. And once more regional and European integration is part of the solution. Latvia shows a good example. There is a need to re-focus and in turn redirect the region in a new positive direction.

We have took tremendous strides forward since the BDF summit was last here in Riga in 2003 and we are again very pleased to work closely with the Government of the Republic of Latvia and Latvenergo as hosts and partners.

THE STATE OF THE REGION

(Co-hosted with Nordic Investment Bank and European Investment Bank)

With the global and European economy in the midst of a fragile recovery, the State of the Region Report provides an assessment of the economic performance, underlying competitiveness, and collaboration efforts across the Baltic Sea Region. The session will feature a discussion of the key observations from the report by Christian Ketels, the lead author, as well as an in-depth look at the current macroeconomic climate by Joachim Scheide. The session will track the current economic dynamics in the Region, looking at both the short-term impact of the weak external economic climate and the long-term trends of the ongoing globalization process. It will also give an update on the joint efforts in the Region to strengthen competitiveness, especially in the context of the EU Strategy for the Baltic Sea Region. With the State of the Region Report reaching its 10th edition, there will also be a look at what has changed in the Region during the last decade.

UPCOMING BALTIC EU PRESIDENCIES: BRINGING MORE EUROPE TO THE REGION OR MORE REGION TO EUROPE?

(Co-hosted with the DeepWater Think-Tank)

As Lithuania and Latvia mobilise for the first time their Presidencies in the EU Council, the main issue is how can these two presidencies help provide new progress in the European and regional integration processes. Jobs, growth and competitiveness are top of the agenda of the crisis ridden Europe. What will be the priorities and focus in this difficult context? Will there be a special Baltic perspective? How will the neighbours in Belarus and Russia figure on the list of priorities? Do the two Baltic Presidencies have their own special interests to promote? Is joining the Eurozone one of them? Join the session for the unique possibilities to inspire future European leadership.

10.30 – 11.45 INNOVATIVE WAYS TO FINANCE BUSINESS DEVELOPMENT

Competitiveness upgrading and economic growth demands investments and access to capital. The financial crisis hit the banks and the economies in the Baltic Sea Region hard as well as in Europe in general. Policies have secured a recovery of the banks and financial sector in our region, but has it been at the expense of companies experiencing insufficient access to capital and seeing tightening of the conditions to obtain loans? Is a credit crunch still an obstacle to growth and can the financing institutions and the sector in general help overcome the situation through innovative financing mechanism and integration of financial instruments? Is the window on the capital markets finally open and for which companies? This year's State of the Region report looks at the situation of the SME sector but how is the access to capital for businesses in general? This session looks at financing from different perspectives and asks whether the Baltic Sea Region is influenced by the financial crisis that still reigns in Southern Europe.

10.30 – 11.45 CROSSING BORDERS TO BOOST INNOVATION

The capacity to innovate and to bring innovation to the market is increasingly important as a driver for competitiveness and growth. But how can it be fostered and how can we increase the economic impact? Internationalisation, cross border learning, knowledge and smart specialisation are all important elements to bring about innovation and they are linked. 
PETERIS ZILGALVIS, Head of Unit, DG CONNECT, **European Commission**

VALDIS DOMBROVSKIS, Prime Minister of Latvia

Prime Minister of Latvia Valdis Dombrovskis was born in 1971 and studied in University of Latvia, Riga Technical University, Mainz University in Germany and University of Maryland in US, receiving M.Sc. degrees both in physics and economics. Before engaging in politics Dombrovskis worked as analyst and chief economist at the Central Bank of Latvia. In 2002 he participated in founding of the political party New Era (currently Unity)). Between 2002 and 2004 he served as Minister of Finance of Latvia. Between 2004 and 2009 Dombrovskis was a Member of the European Parliament.



working in the Budget Committee. In March 12, 2009 Valdis Dombrovskis assumed position of Prime Minister of Latvia and has managed to turn Latvia from the fastest falling EU economy into the fastest growing EU country. Under his leadership Latvia successfully implemented an austerity package worth 17% of country's GDP, performed a number of successful structural reforms and regained trust in financial markets, thereby restoring sustainable growth. Despite many unpopular decisions his governments have had to take to overcome crisis, Dombrovskis remains one of the most popular politicians in Latvia. He has been re-elected twice (in 2010 and 2011), currently serves his third term as a Prime Minister and has become the longest-serving head of government in Latvia since restoration of independence in 1991. His achievements have been recognized by the international community; 2012 he received the Friedrich August for Hayek Foundation International award, the American Institute on Political and Economic Systems Polak award and the Baltic Assembly medal. Also, Valdis Dombrovskis has presented Latvia's experience in overcoming crisis in World Economic Forum 2013 which took place in Davos, Switzerland, various international conferences organized by IMF, World Bank, Horasis and other institutions, as well as a number of regional and local forums and discussion panels. Valdis Dombrovskis and Swedish economist Anders Åslund have co-authored a book "How Latvia Came Through the Financial Crisis" published in Latvian and English languages.



BDF COMPETITIVENESS ADVISORY COUNCIL FOR THE BALTIC SEA REGION

In these years, the Baltic Sea Region in many ways serves as a role model. But to be successful in regional development and integration, competitiveness, growth enablers and obstacles to trade and investments must be clearly placed at the heart of all endeavours, including the EU strategy for the Baltic Sea Region. The State of the Region Report has for many years provided insight into the facts.

BDF has invited leading economists, business representatives and policy makers to an informal discussion on how to strengthen the regional cooperation in the field of competitiveness. The meeting will discuss a proposal to establish a Competitiveness Advisory Council for the Baltic Sea Region. Such an initiative could serve as an informal advisory board for the EU Strategy, launching concrete proposals and urging decisionmakers to keep the competitiveness of the Baltic Sea Region high on the agenda as a key topic for regional cooperation, and a platform for debate among public and private key stakeholders as to how to improve the region's competitiveness. The meeting will also discuss how the monitoring, analysing and reporting of the region's economic development can be continued.

The outcome of the meeting will be briefly presented at the subsequent Plenary Session "Competitiveness, Investments and Business Development – Manufacturing the Future".

The meeting takes place Wednesday 29 May, 12:00-13:15 in the Latvian Ministry of Foreign Affairs, 3, K.Valdemāra Street, Riga (Room 140), close to BDF Summit Venue. The meeting is *Upon Invitation Only* and will be chaired by BDF Chairman Hans Skov Christensen.



▶ ONE BSR

ONE BSR is an international project, implemented by 17 partners, which functions as an umbrella project for branding the Baltic Sea Region (BSR). The project aims to identify and produce elements for the Baltic Sea Region's image and identity.

Vision:

To increase the Baltic Sea Region competitiveness by branding it as one unity

Mission:

To pool resources in attracting investors, tourists and talents to the region, to increase people's interest in the common good of the Baltic Sea Region

Objectives:

To market the whole region and its different parts by developing joint promotional services and test them in practice, to make positive publicity of the BSR lifestyles and to encourage the "we-feeling" of the Baltic Sea Region

Internationally, the Baltic Sea Region is increasingly becoming a distinct macro-region in Europe. The level of cross-border cooperation has traditionally been very high in most areas, and now new efforts are being made, which include a more systematic and structured way of promoting and marketing the Baltic Sea Region globally.

This includes a closer cooperation between the Baltic Sea Region Investment Promotion Agencies (BSR IPAs) on national and metropolis levels. Until now many IPAs were committed to work together but in practice it has been challenging since a neutral platform has not existed. ONE BSR provides such a neutral platform.

The idea behind the BSR IPAs initiative is to enable the national and regional organisations, responsible for inward investment promotion throughout the Baltic Sea Region, to communicate better and ultimately pool resources in attracting foreign investment. The evident challenge is to find and develop common denominators between the IPAs since they are each other's competitors in attracting inward investments. The BSR IPAs project aims at overcoming these challenges and proving that all parts of the region could be better off if the partners join efforts, pool resources and focus on synergies. Therefore, the overall objective is, to by creating a common and coherent approach to investment promotion, marketing and communication, strengthen the Baltic Sea Region's image as an appealing investment area and ultimately attract more investments into the region as a whole.

Baltic Development Forum took a coordinative role to ensure that the IPAs to come together regularly and discuss common challenges and cooperation opportunities.

The **ONE BSR** is a flagship project within the EU Strategy for the Baltic Sea Region, which has been adopted by the Member States of the European Union. The project seeks also to establish cooperation links to partners outside the EU, especially with St. Petersburg and the North-West district of Russia.

A MACRO-REGIONAL NEWS WEBSITE IN THE BALTIC SEA AREA

Innovative communication as a means of increasing understanding and prosperity

Under the umbrella of the EU-financed ONE BSR (WP6), Baltic Development Forum (BDF) has launched a website that will emphasise independent journalistic news on all levels – to the citizens, policy-makers, business, stakeholders, experts and the creative community of the region.

The overall objective of the website is to improve information exchange and the crossborder communication between the countries of the region, especially the countries that form part of the EU's macro-region in the

newsWave



Baltic Sea Region. Information and communication has been identified as a critical aspect in the work towards establishing a distinct regional identity.

At present there is no independent news media covering the Baltic Sea Area as such. The new website is the first regional communication platform/news exchange of its kind, communicating and sharing trans-national interesting topics – published on the website and immediately (re)distributed by e-mail, Facebook, Twitter etc. to news editors/ exchange sites all over the region and to stakeholder magazines and websites.

In order to make this exchange of news lively and trustworthy, it has to be selected on the basis of journalistic news criteria (actuality, importance and interest) and edited in a simple, everyday language - published in a "catchy" form. News gathering and blogs will partly be in the hands of young talents recruited from all countries around the Baltic Sea – we call them news spotters.

BDF has a role as horizontal coordinator within the EU Strategy for the Baltic Sea Region and will coordinate and cooperate with other organisations and project-leaders to communicate results and reports to the public. Relevant EU-news will have priority – with the aim to decrease the distance between the EU to the citizens. Likewise we will work with international organisations, including the Council of the Baltic Sea States, Nordic Council of Ministers and others.

BDF is also a think-tank and therefore we will ourselves produce new results on identity and on the Baltic Sea regional "we-feeling". Results, debates and comments from other think-tanks will be uploaded on the website, and BDF will make use of its exclusive database for other projects and sending out newsletters. BDF will take on the editing role of the new website as a non-government organization: The "arms length principle" is important for BDF, having a track record dating back to 1998, known in the region for its multi-stakeholder role (cooperation with cities, regions, governments, private/ public enterprises and trade organizations) and for its ability to organise greater tasks across borders involving business as well as academia.

It is essential that the new website is politically neutral, balanced, informative, open minded and using the best tradition of independent public service journalism. To guide BDF as editor, an international board will be established.

- Daily BSR news from news spotters and from monitoring media
- Blogs and other external perceptions of the BSR

- Information on/links to BSR countries and relevant web pages

The aim is a sustainable news website for the Baltic Sea macro-region

Communicating regional news, identity debates and EU-project results to an audience not used to cross-border information is a difficult task. A website with the ambition to improve information exchange with the overall aim to promote a more distinct regional identity or "we-feeling" is an even more difficult purpose.

On top of that the recruitment and engagement of young volunteers – news spotters from all countries around the Baltic Sea - to monitor the news coverage and write short extracts on Baltic Sea Region topics – as well as blogging on the daily life in their area – can be labelled as a unique experiment.

BDF is certain however that it will succeed with the help and support from all good parties, building upon the extraordinary public interest for closer cooperation in the region and using the impetus of the EU-strategy. We have a clear aim: a sustainable website for the Baltic Sea macro-region after the two year pilot period – partly financed by sponsors/advertisers and the EU.

RENSOL Regional Energy Solutions

With a new year, the RENSOL project is going at full speed. This year we are pleased to welcome new partners who will share their competences and knowledge, and thus provide an added value to the project.



The RENSOL project, or "Energy Efficiency and Renewable Energy Solutions in Kaliningrad Oblast" is an international energy project within the framework of priorities of the Northern Dimension, partly funded by the European Union. The project is being implemented on the territory of the Kaliningrad Oblast with ambitions to provide smart energy solutions, applicable even in the whole North-West Russia. The project is led by Baltic Development Forum in close cooperation with project partners in Kaliningrad and from the Nordic countries. The objective of the project is to identify the latest energy efficient and renewable energy solutions in Nordic countries and adapt them to the Kaliningrad context on a concrete pilot objects. The project is also targeted at development of financing mechanisms behind energy solutions, and training sections in energy management standards, ISO 50001.

The project is finalising its 1st phase and a report on Nordic solutions to improve energy efficiency in buildings as well as adaptation of the solutions to the local context in Kaliningrad, will be soon published. Lappeenranta University of Technology in close cooperation with partners in Kaliningrad studied the concrete pilot cases and the report will provide a good overview of what is the situation, what can be done and under what conditions.

Baltic Development Forum will lead the implementation of activities aimed at identification of best available financial practices and for reaching the best results we will try to mobilise our relevant network – international financial institutions, private banks and companies – and together outline recommendations. A planned seminar in 2013 on financing modeling and mechanisms in energy efficiency will provide us an opportunity to discuss the issue with relevant stakeholders.

Furthermore, we have moved further with the pilot cases that are now being analysed by elaborating a series of specified engineering solutions, needed for increasing energy efficiency.

With this starting point and plans for future we are opening a new chapter this year and kindly welcome any good ideas that will help us to develop the project to a success story.

Not since the EU enlargement towards Central and Eastern Europe in 2004 has the interest in regional and European integration been so vivid, despite the recent economic and financial crises. In order to maintain the EU strategy and regional integration as a long term process (and a vision for other European regions), we consider it necessary to establish an open and more integrated forum for open discussions on the state of regional affairs and to create a forum of experts. The idea to establish a (virtual) think tank for the Region emerged a few years ago and has been discussed at different forum, such as the BDF summits. It was intended as an attempt to create a common cross-border

platform, aimed at raising awareness, mutual understanding and greater visibility, enhancing the political dialogue in the Baltic Sea Region, and offering expert advice to politicians, administrations and various stakeholders in the region.

With the support of the Baltic Development Forum, the Konrad Adenauer Foundation (Riga/Berlin), the Nordic Council of Ministers, the Centre for Baltic and Eastern European Studies (CBEES) at Södertörn University (Stockholm), and the Department of Northern European Studies at Humboldt University (Berlin), this (virtual) endeavour could be realised. Although there is no haptic space or established institution, a vivid collaboration and intellectual exchange of experts around our common Sea has materialised since 2010. The first result of our joint ambitions and endeavours was the Political State of the Region Report 2011. This was followed up with reports in 2012 and again this year. The report allows for evaluation of the political developments of the Region and domestic developments within the countries of the Region have been put into a wider regional perspective. By means of these reports, Deep Water has become known to and will gain further recognition from a wider public. We are prepared to continue our endeavours as a group of experts entirely independent of governments, international organisations and corporate actors. As a means of reaching out to a bigger audience and with hope to further the debate on regional affairs, a special website will be developed during 2013.

BDF 2013 Strategy and priorities

BDF will continue to act as an independent platform that works for integration, dialogue and cooperation in the Baltic Sea region.

BDF will carry out its role in four different ways:

 as a Summit organiser and facilitator for decision-makers;

as an agenda setting think-tank that provides new data and information;

 as a communication and information platform that facilitates debate and the development of a stronger regional identity;

and as a project implementer that carries out concrete cooperation projects.

The EU Strategy is particular important, and BDF will support it so that it does not lose momentum and political support since it represents a major opportunity for the region. BDF will work closely with the European Commission and regional partners on the updated EUSBSR including its new Action Plan. BDF will also go beyond the EUSBSR and work with Russian partners, not least through the CBSS and the Northern Dimension partnerships.

Increasingly, BDF's role is to ensure that the private sector takes a more active part in setting the priorities for the region. Public-private cooperation is essential to making better use of the region's potential and to improving the region's economic growth, competitiveness and innovation capacity. Generally, the Baltic Sea Region is doing well in terms of economic growth of the Baltic States is impressive. In 2013 BDF will focus on their international "come back" and the role the states play in the region. It will be taken up at the 2013 BDF Summit in Riga, Latvia.

1) ACTIVITIES

15th BDF Summit 29-30 May 2013 in Riga

The 2013 Summit will be organised together with the Latvian Government and in conjunction with a meeting of the Baltic Council of Ministers. As always the Summit represents the culmination of BDF's work and it will bring together key decision-makers. The main topics will be competitiveness, business development and investment promotion, and we will try to have a clearer business related profile compared to the previous years. We will work with local business organisations, companies and institutions in order to bring out this focus which will also be directed mainly towards the Baltic States.

Baltic Business Arena - BBA

One way to improve the business networking is to continue developing a matchmaking event between companies in the region. It will be done together with Tillväxtverket and Swedish and Latvian partners. It will also be more integrated with the Networking and Exhibition Village. In Riga the Foreign Investors Council in Latvia (FICIL) will also be invited to take a more active part in the event.

Water: Green and Blue Growth for a Bluer Baltic Sea

Following the successful water conference 26 November 2012 in Copenhagen, BDF is now moving more actively in the water sector. BDF has proposed to the Danish Presidency of HELCOM to organise a stakeholder conference back-to-back to the HELCOM ministerial 2-3 October in Copenhagen. It will include

both the Blue Growth sector, which has been promoted by the European Commission in the past year, and the Green Growth water sector.

2) REPORTS AND PUBLICATIONS

Throughout 2013, BDF will again deliver topical and thoughtful reports which will in turn provide a concrete base for discussion and research in different parts of the region. The following reports will be issued:

State of the Region Report 2013 -

Prof. Christian Ketels will again write the State of the Region Report, co-financed by EIB and NIB. The presentation will figure prominently on the BDF Summit agenda. One important hypothesis which the report will address is whether a new and attractive regional value chain has emerged after the economic and financial crisis. Also the role of SMEs in the region's economic performance. The issue of access to financing is not least important to SMEs and the region's opportunities to improve competitiveness. This year the report has been published in 10 years. It is a good occasion to reflect on the role of the State of the Region Report.

Political State of the Region Report 2013 -

A third report of the research network will be presented at the Summit in Riga. Prof. Bernd Henningsen, Humbolt will the work and Tobias Etzold, Stiftung Wissenschaft und Politik, will be editor of the report which will have app. 15 articles including a country chapter of the 12 countries in the Region. Nordic Council of Ministers is co-financing the report. Konrad Adenaur Stiftung in Riga will help financing a meeting of the researchers (the Deep Water research network) in Riga.

Report on Identity -

BDF will elaborate a report on regional identity as part of the formal role as Horizontal Action Leader of the EUSBSR. Thereby, BDF follow up on the report "On Identity – No Identity" that was presented in 2011. Prof. Bernd Henningsen will be BDF's academic advisor and he will identify the co-writers of the report.

Financial models on energy efficiency projects in Russia –

BDF will present a study on this issue which has great potential: the market for energy efficiency in Russia is huge and the benefits to the Russian society and economy are very big. If the right financing models are found then a major obstacle will be removed.

3) ENERGY/RUSSIA: RENSOL

Within the Rensol energy efficiency project which is co-financed with the EU's Northern Dimension Partnership on the Environment, BDF will primarily focus on financing mechanisms and modelling in 2013 as well as support the multiplication of the positive results found in Kaliningrad. Finding good financing tools, practices and models is extremely interesting issue, since rapidly expanding residential areas have a huge untapped potential for improvements in energy saving and energy efficiency. BDF will lead the implementation of activities aimed at identification of best available practices and technologies. The main focus is on the municipal level.

4) COMMUNICATION AND INFORMATION - NEWSWAVE

Under the umbrella of the EU-financed ONE BSR (WP6), BDF as editor-in-chief will launch a news website that will emphasise independent journalistic news on all levels – to the citizens, policy-makers, business, stakeholders, experts and the creative community of the region. The overall objective of the website is to improve information exchange and cross-border communication between the countries of the region, especially the countries that form part of the EU's macro-region in the BSR. The main aim in 2013 is to get the website fully developed and known throughout the region.

5) COMPETITIVENESS, GROWTH AND PUBLIC-PRIVATE PARTNERSHIP

▶ Investment Promotion Agencies - BDF will convene 2-3 meetings on the BSR Investment Promotion Agencies (IPA) throughout 2013 in order to find common interests and shared priorities in their work of attracting more investments to the region. BSR IPAs initiative under the ONE BSR project will strive to strengthen the perception of the BSR as a coherent region, attractive to foreign investors. BSR IPAs enables active and interested public-sector organisations to meet regularly to discuss cooperation opportunities and ultimately attract more investments which will lead to higher competitiveness and prosperity in the region.

ICT/Digital agenda - BDF intends to follow up on the "Priorities towards a Digital Single Market in the BSR" report from June 2012. BDF will enhance an already established connection with the European Commission about how the BDF initiative can be aligned with EU initiatives such as the Connecting Europe Facility (CEF) and EU Digital Agenda. Furthermore engage in joint activities and conferences with BDFs members and partners, such as Microsoft, Stockholm city, Investment Promotion Agencies BDF will focus on the Nordic/Baltic strength positions within ICT and how we can inspire the rest of Europe in bringing out the economic potential of the sector.

▶ Transgovernance - The EU co-financed transport project intends to demonstrate how multi-level governance models, tools and approaches can contribute to a better alignment of transport policies in the BSR. This is expected to increase commitment of public and private stakeholders to achieving greener and more efficient transport in the Baltic Sea Region, in line with the objectives of the EUSBSR. BDF's role is to facilitate the policy dialogue among stakeholders.

SUMMIT 2012 CONCLUSIONS

The 2012 BDF Summit and European Commission's Annual Forum conference turned out to be a very timely reminder to all stakeholders to embrace the EU negotiations ahead of the 2014-2020 financial period to make sure, that partnership agreements and operational programs reflect the needs of the EU Strategy for the Baltic Sea Region. A lot of enthusiasm and commitment still exist in the Baltic Sea area, documented by the attendance of more than 850 participants at the Summit/Annual Forum in Copenhagen/Malmo.

The general outcome of the Conference was positive: many stakeholders were interested and willing to take an active part in the macroregional development and the global connectivity of the region. One important message was a commitment to ensure that the Regions vast and sometimes difficult geographic conditions do not impede trade, mobility and energy reliability. That is in line with the Strategy's new "Connect the Region" objective that the European Commission had proposed in its 2012 Communication on the Strategy.

NOW IS THE TIME TO LAY THE FOUNDATION OF THE NEXT 7 YEARS OF CO-OPERATION

Future investments, partnerships and new regional projects were key issues during the three days of conference. The prevailing economic crisis in Europe, and the EU-negotiations of the 2014-2020 financial period, called for new commitment and new ways of co-operation on all levels in the Baltic Sea Region.



Johannes Hahn,

Commissioner for Regional Policy, stressed that future investments in better connections for transport and energy, and networks for research and innovation, were vital to deliver the results that citizens wanted. He underlined that now was the chance to take a fresh and comprehensive look at funding and policy design to establish a more effective base for the next seven-year funding period.

GREATER INVOLVEMENT OF THE PRIVATE SECTOR



The BDF chairman, Hans Skov Christensen, in his speech at the conference stressed that Baltic Development Forum would do its best to involve the private sector more strongly - therefore a new regional Competitive-

ness Advisory Council would be convened by BDF to present views on priorities and policies. The State of the Region Report provide valuable insights into the challenges and opportunities and the region's competitiveness needed to be firmly placed in the heart of the regional cooperation.

IMPROVING CONNECTIVITY

The panel discussions revealed the importance of promoting "connectivity" in all its aspect as it will create growth and jobs. Delivering concrete results will require co-operation at all levels and must include private partners. **Cornelia Pieper**, Minister of State, Foreign Federal Office, Germany, pointed out the common history and shared ideas of freedom and welfare will continue to bind the countries tighter together. She also hoped that the progress in co-operation with Russia that has developed under German Presidency of CBSS – Council of Baltic Sea States – would continue.

According to Vice-President **Siim Kallas,** Commissioner for Transport, infrastructure is well placed to help re-dynamise the European economy: "With smooth, integrated networks and proper connections across Europe, we can give our economy a good chance to grow," Mr. Kallas said, mentioning United States figures showing that infrastructure investment spending created about 18,000 total jobs for every \$1 billion in new investment spending.



Vytautas Leskevi-

cius, Vice-Minister in the Ministry of Foreign Affair, Lithuania, called for the removal of existing economic obstacles in the region. He pointed at the prosperity gaps that were still obvious throughout the BSR.



Viktors Makarovs,

Parliamentary Secretary, Ministry of Foreign Affairs, noted that success in enhancing the connectivity in the region depended on stronger political commitment.

BOOSTING THE ATTRACTIVENESS



Esko Hamilo, Under-Secretary of State, Ministry of Foreign Affairs, Finland, stressed that individual countries have to begin to strengthen co-operation by themselves, fostering sustainable growth, innovation and competitiveness. "We have to be strong to cooperate. You put weak and weak together, and you do not come out strong." He said.

His recipe was building missing transport, energy, and communication links, and he found a certain readiness in the region to explore the possibilities of public -private partnerships alongside the development in the internal market. Mr. Hamilo pointed out that the Baltic Sea Region consisted of 60 million inhabitants with considerable purchasing power.

ENERGY

We are making progress — but relatively slow progress. That was the message of Deputy State Secretary in the Danish Energy Agency, **Hans Jørgen Koch** at the session "Convergence or Competition: Energy Agenda for the Baltic Sea Region? "

According to Mr. Koch, the countries of the BSR are increasingly being interconnected by pipelines and high-voltage corridors, but more must be done in order to bring competition into markets where it does not exist, alon side while at the samting all opportunities to cooperate on topics that cannot be dealt with on the regional and national levels.

Director-General for Energy at the European Commission, **Philip Lowe**, emphasised that several EU Member States in the Baltic area are entirely dependent on only one supplier through principally one pipeline for certain sources of energy. That in itself is an obstacle in creating choice and competition in the market for energy supplies. The goal must be to remove these energy islands – countries being entirely dependent on one source of energy – from map of the EU, Lowe said.

RUSSIA

More chairs had to be brought into the auditorium in order to seat keen listeners, attracted by the seminar title "Making success stories with Russia". The session confirmed that there are many cases of a

fruitful cooperation involving EU and Russian partners established at various levels and engaging various stakeholders. However, further efforts are needed to better publicise these achievements and provide inspiration for other stakeholders interested in developing cooperation between EU and Russian partners, was the general opinion among the speakers.

Several components of the EU Strategy for the Baltic Sea Region (EUSBSR) require co-operation with Russia in order to achieve results. Despite growing interest in cooperating with Russian partners, this effort has achieved varying degrees of success and it is widely recognised that this cooperation should be intensified. However, the strategy states, it is neither reasonable nor realistic to expect non-member states to sign up to an EU Strategy. Therefore, common interests have to be found and common denominators for joint activities in the Baltic Sea Region identified.

ARE THE BALTIC SEA REGION COUNTRIES LEADERS IN GREEN GROWTH?



Dan Jørgensen,

Member of the European Parliament, Denmark, took up the issue of green growth from the State of the Region Report: "My provocative question is 'Are there any signs that we will be a leading region on this

issue? ' Surely there are more signs that some countries will go ahead and maybe join forces with other countries, other places in the world, then there are signs that we as a region really do this in collaboration," was the question to Mr. Ketels.

agreed with the more pessimistic notions from Dan Jørgensen about the Baltic Sea Region being a leader in the green growth area saying: "The investments made, and the determination to be the new leader in these

markets is huge from countries like US, China and Germany. So success in this region will not come automatically and we need to be very clear that only because we see ourselves as very ecologically oriented, that does not make us world winners on this."

POLITICAL STATE OF THE REGION REPORT

The 2012 Political State of the Region Report focused on Russian Baltic Sea Region policies, the development of the Russian Baltic Sea exclave Kaliningrad, and two countries outside the core region that were not covered in the first report -Norway and Iceland - and their relationship to the BSR and BSR policies. The article on Russia deals with the involvement of the country in regional co-operation, the attempts of the other countries of the region and the EU to involve Russia, and related difficulties. The chapter on the Kaliningrad area draws an upto-date sketch of the situation of this Russian Baltic Sea exclave, providing an overview of progress, relevant issue areas and remaining challenges, risks and difficulties. Norway and Iceland have a special relationship with the BSR, as they are geographically not part of the region, but participate in most of the regional co-operation arrangements. As for these countries, the most interesting questions are whether they are still real outsiders in the region or have become a kind of insider or semi-insider. If they are considered to be in, the next question is whether they are in for real, whether they have a genuine interest in the region or whether the interest and engagement is rather halfhearted and symbolic only.

The Republic of Latvia is located in the center of North East Europe where the East meets the West. Its strategic location has made it an international crossroad for trade, commerce and cultural exchange since ancient times. Nowadays Latvia is an important point in the East-West trade. Cooperation with its neighbors in the Baltic Sea region and development of strategic global ties is a priority and a goal for the Government of Latvia.

After the short existence in the first half of the 20th century, Latvia regained its independence in 1991. Ever since then Latvia has developed rapidly and has sought every opportunity to establish itself more prominently in the international arena. After joining the European Union and NATO in 2004, the next goal of the Government of Latvia is joining the Euro zone in January 2014 to further enhance the economic development of the country. After rapid economic growth during 2005-2007 and losses during global financial crisis, the main task of the economic policy of Latvia is to establish a good foundation for sustainable growth. Currently, the main economic driver of Latvia is export. Economy is balanced both internally and externally and Latvia's GDP growth is the most rapid in the EU.

At the same time Latvia highly values its cultural heritage and much is done to preserve it for the next generations. Excellent examples of these efforts are the regular and widely popular national song and dance festivals that gather thousands of participants and even more visitors. Moreover, in 2014, the capital of Latvia, Riga, will be the cultural capital of Europe.

I think it is a very big prize and it is a general prize, so it goes to science, research and development," said Professor of Condensed Matter Physics Lars Börjesson, upon receiving this year's Baltic Sea Award at the Gala Dinner Monday evening at the venue "Docken"during the Baltic Development Forum Summit in Copenhagen.



Börjesson chairs the steering committee at European Spallation Source and MAX IV laboratory to be built outside of Lund in the southern part of Sweden. The spallation facility is most likely to revolutionise material research in Europe, making it possible to examine new materials on an atomic and molecular scale. Lars Börjesson is hesitant to predict exactly what to expect from the new facilities. "Almost all scientific forecasts have turned out to be wrong. What we can say is, that we will get a truly magnificent tool for doing physics and also life science," said the Swedish professor.
